was freed after demolishing the construction. ADM Jain said there are reports that he owns land in Indore and other place in the state capital. The state government will take action after verification.

The ministers should be in Bhopal on Mondays and Tuesdays, and on other days, they should be in their constituencies, said Chief Minister Shivraj Singh Chouhan.

He made the above statement at a cabinet meeting on Monday. Chouhan asked the ministers to review the work of their departments on

Mondays, and there will be cabinet meeting on Tuesdays. They should also fix time for meeting the legislators.

During the cabinet meeting, the ministers should prepare the briefings of their departments and officers will help them, Chouhan said. He said the ministers would soon be made in charge of districts and should visit those areas twice a month.

During the tour, they

should make night halt, review the construction work and interact with public. Chouhan further said he would review the work of each department from time to time.

For government work, CM Monit System has been set up, he said, adding that functioning of each department will be reviewed through it. Road map to Atmanirbhar Madhya Pradesh will be put up on August 15, he said.
